1. Category of Membership

Ordinary Membership is open to any Malaysian resident company which owns at least one (1) vessel registered in Malaysia and which meets all the requirements of the Merchant Shipping Ordinance, 1952 and other statutory requirements in force relating to the registration of vessels in Malaysia.

Associate Membership is open to any Malaysian resident company involved directly or indirectly with the shipping industry.

2. Entrance Fee

An entrance fee of **RM1,000 (for Ordinary Member)** or **RM500 (for Associate Member)** in crossed cheque payable to Malaysian Shipowners' Association is to be enclosed with this application for membership. The fee will be refunded if the application is rejected.

3. Subscription

Ordinary Members shall pay a subscription rate based on a two tier system as follows:

a) **Vessel Due**

RM100 per vessel per month owned at any time during the month up to a maximum of RM400 for four (4) vessels.

b) **GRT Due**
