Based on Part IIA of the Registry of the Merchant Shipping Ordinance, 1952 (1) Subject to subsection (1B), a ship shall not be deemed to be a Malaysian ship unless it is owned wholly by persons of the following descriptions, namely-

NOTES

1. Category of Membership

Ordinary Membership is open to any Malaysian resident company which owns at least one (1) vessel registered in Malaysia and which meets all the requirements of the Merchant Shipping Ordinance, 1952 and other statutory requirements in force relating to the registration of vessels in Malaysia.

Associate Membership Category A (ship-owning) is open the registry to any Malaysian resident company which own at least one (1) vessel with 300 and below GRT for each vessel.

Associate Membership Category B (non- shipowning) is open to any Malaysian resident company involved directly or indirectly with the shipping industry.

Associate Membership Category C (**Affiliate**) Affiliate members shall be open to any Malaysian resident Associations involved directly or indirectly with the shipping industry.

2. Entrance Fee

An entrance fee of **RM1,000** (for Ordinary Member) or **RM500** (for Associate Member) in crossed cheque payable to Malaysian Shipowners' Association is to be enclosed with this application for membership. The fee will be refunded if the application is rejected.

3. Subscription

Ordinary Members shall pay a subscription rate based on a two tier system as follows:

a) Vessel Due

RM1800 per owned vessel per year subject to a maximum of RM7200 for four (4) vessels.

b) GRT Due

The maximum total subscription payable by any one member shall not exceed RM2,500.

Associate Members Category A shall pay an annual subscription of Ringgit One Thousand Two Hundred (RM1,200/-) for the first' vessel owned at any time during the calendar year and Ringgit Twenty-five (RM25/-) for each subsequent vessel.

Associate Members Category B & Category C shall pay an annual subscription of Ringgit One Thousand Two Hundred (RM1,200/-).

- iii. Any Associate Member which satisfies the requirement set out above may apply in writing to the Honorary Secretary for Ordinary Membership.
